Remedies

You are also kindly requested to indicate, in future correspondence, the kind of remedies you would like to obtain from the State party in case the Committee concludes that a violation of the Covenant has taken place in the case you have submitted, unless you have already indicated these remedies in your initial submission.

Confidentiality

Please be aware that final decisions adopted by the Human Rights Committee are made public. Therefore, if the author wish for his/her identity not to be disclosed in the final decision, you are kindly requested to indicate so as soon as possible. Kindly note that, due to the level of publicity the Committee's decisions usually receive (including dissemination via Internet, which thus makes the correction and/or deletion of data
